

The Fillmore County Board of Supervisors convened in open and public session at 9:00 a.m., March 22, 2011, in the Courthouse Boardroom in Geneva, Nebraska with Chairman Capek presiding. Members present were Noel, Yates, Simacek, Mueller, Galusha, and Cerny. The County Clerk was present to record the minutes of the meeting.

Notice of the meeting was given by publication. A copy of the publication is on file in the County Clerk's office. All proceedings hereinafter shown were taken while the convened meeting was open to the public. Agenda was approved as presented. The Chairman noted that the public meeting guidelines are posted as required by law and available for public distribution if requested. The meeting adjourned at 2:38 p.m.

## **MINUTES APPROVED**

Chairman of the Board, Capek approved the minutes of the March 8, 2011 Board meeting.

#### PUBLIC HEALTH SOLUTIONS

Debbie Wendelin with Public Health Solutions informed the Board that they have received a grant to assist residents with the removal of lead based paint in homes. They have sent contractors to training so that they know how to take care of the lead based paint properly. Public Health is also working with Blue Valley Community Action and Southeast Nebraska Development District.

#### 2009/2010 AUDIT

Joleen Stroyek with Contryman Associates, PC presented the audit for fiscal year ending June 30, 2010 to the Board.

#### NOXIOUS WEED BOARD

Todd Boller, Noxious Weed Superintendent informed the Board that Darlene Vodicka resigned from the Noxious Weed Board and they would like to appoint Carol Hoarty to fill the vacancy.

After discussion, Noel moved and Simacek seconded the motion to appoint Carol Hoarty to the Noxious Weed Board effective immediately and ending December 31, 2015. Upon roll call, the vote was as follows:

## **GENEVA NORTHWEST PROJECT**

After discussion, Mueller moved and Simacek seconded the introduction of the following resolution:

## RESOLUTION 2011 - 11

WHEREAS, Fillmore County is proposing a transportation project for which it would like to obtain Federal funds;

**WHEREAS,** Fillmore County understands that it must strictly follow all Federal, State, and local laws, rules, regulations, policies and guidelines applicable to the funding of the Federal-aid project; and

**WHEREAS,** Fillmore County and Nebraska Department of Roads (NDOR) wish to enter into a Project Program Agreement setting out the various duties and funding responsibilities for the Federal-aid project.

**BE IT RESOLVED**, by the Board of Supervisors of <u>Fillmore County</u> that Ray Capek <u>Chairperson of the Board of</u> <u>Fillmore County</u> is hereby authorized to sign the attached Project Program Agreement between <u>Fillmore County</u> and the NDOR.

<u>Fillmore County</u> is committed to providing local funds for the project as required by the Project Program Agreement.

Brenda Sherwin presented the budget for 2011-2012 for the Fillmore County Rural Transit in the amount of \$20,036.00, which will be discussed later this summer. They also presented documents for Federal and State funding.

#### RURAL TRANSIT FUNDING

After discussion, Mueller moved and Yates seconded the introduction of the following resolution:

## **RESOLUTION 2011 - 12**

**WHEREAS,** there are federal funds available under Section 5311 of the Federal Transit Act and for the Nebraska Public Transportation Assistance Program, and

WHEREAS, Fillmore County desires to apply for said funds to be used to provide public transportation in Fillmore County.

**NOW THEREFORE, BE IT RESOLVED;** that the Fillmore County Board of Supervisors hereby instructs the Fillmore County Clerk to apply for the above said funds. Said funds are to be used for Fillmore County Rural Transit Transportation operations in the Fiscal Year 2011-2012 Application for Public Transportation Assistance.




