MINUTES APPROVED


Chairman of the Board, Sluka declared the minutes from the March 8, 2022 meeting approved as presented.

DISCUSSION REGARDING POTENTIAL CLOSURE OF RAILROAD CROSSINGS FOR UNIT TRAIN LOADING ON MANNING RAILROAD

Kent Manning was present for discussion regarding the potential of temporarily closing railroad crossings for the Manning Railroad while the unit train is loaded. Highway Superintendent, Pat Halbur has been in contact with NIRMA (Fillmore County's insurance carrier) regarding the proper way to close the affected roads.

AGREEMENT WITH SPEECE LEWIS ENGINEERS TO PROVIDE ENGINEERING SERVICES

OCCUPY COUNTY RIGHT-OF-WAY PERMIT

Cerny moved and Neiman seconded the motion to approve the following occupy county right-of-way permit as presented by the Highway Superintendent:

Nodal Seismic, LLC on behalf of Natural Hydrogen Energy, LLC – one-time single use of 2D Seismic Acquisition Test on Road J between Road 1 to Road 10 and Road 5 and Road 6 between Road E to Road Q all in Fillmore County. The owner will cooperate fully with the officials of Fillmore County and keep them fully and immediately informed of all construction or maintenance work required in the county right-of-way.

OCCUPY COUNTY RIGHT-OF-WAY PERMITS

Windstream Nebraska, LLC – bury telecommunications line on Road O between Road 24 and Road 25, Section 12 to Section 13, Glengary Township. The owner will cooperate fully with the officials of Fillmore County and keep them fully and immediately informed of all construction or maintenance work required in the county right-of-way; and

O'C & O'C, Inc. – bury electric line on Road B between Road 7 and Road 8, NE ¼, Section 7 to E ½ of the SE 1/4, Section 6, West Blue Township. The owner will cooperate fully with the officials of Fillmore County and keep them fully and immediately informed of all construction or maintenance work required in the county right-of-way.

UPDATE FROM SHERIFF'S OFFICE

This allows them to answer the phone as well as radio traffic. Should have the new cars in service within the month and will be getting the new cages installed in all the vehicles that do not have one.

AGREEMENT WITH GLENWOOD TELECOMMUNICATIONS

Scott Kirlin, Sr. Sales Executive with Carrier Corp. discussed with the Board regarding repairing the leak in the condenser for the chiller and the possibility of replacement due to age and current refrigerant not being available anymore.
