The Fillmore County Board of Supervisors convened in open and public session at 9:05 a.m., November 14, 2023, in the Boardroom of the Courthouse in Geneva, Nebraska with Chairman Sluka presiding. Members present were Noel, Neiman, Graham, Harre, Cerny, and Lightwine. The County Clerk was present to record the minutes of the meeting.

Notice of the meeting was given by publication and a copy of the publication is on file in the County Clerk's office. All proceedings hereinafter shown were taken while the convened meeting was open to the public. The agenda was approved as presented. The Chairman noted that the public meeting guidelines are posted as required by law and available for public distribution if requested. The meeting adjourned at 12:00 p.m.

MINUTES APPROVED

Chairman of the Board, Sluka declared the minutes from the October 24, 2023, meeting approved as presented.

HOSPITAL USDA BONDS

Chris Nichols, CFO with Fillmore County Hospital informed the Board that the Hospital Board had authorized the Hospital Revenue Bonds from the USDA for their construction project.

After discussion, Neiman moved and Graham seconded the motion to approve the closing certificate and letter pursuant to Section 23-3504(4), Reissue Revised Statutes of Nebraska, as amended, approves (i) the issuance by the Fillmore County Hospital of its Hospital Revenue Bonds, Series 2023, and the pledge by the hospital of Hospital revenues to the repayment of said Hospital Revenue Bonds in the amount of \$5,000,000.00.

OCCUPY COUNTY RIGHT-OF-WAY PERMIT

After review, Neiman moved and Lightwine seconded the motion to approve the following occupy county right-of-way permit as presented by the Highway Superintendent:

Brian & Jodi Hartman – bury gas and electric line along Road F between Road 14 and Road 15, NE ¼, Section 22, Fairmont Township. The owner will cooperate fully with the officials of Fillmore County and keep them fully and immediately informed of all construction or maintenance work required in the county right-of-way.

DISCUSSION REGARDING INTERIM HIGHWAY SUPERINTENDENT WITH SPEECE LEWIS

Tim Farmer with Speece Lewis informed the Board that he does currently serve as the Highway Superintendent for Jefferson County and presented a contract if the Board would select them to fill-in until a Highway Superintendent could be hired.

After review and discussion, Lightwine moved and Noel seconded the motion to appoint Tim Farmer with Speece Lewis as the interim Highway Superintendent effective November 14, 2023 and ending December 31, 2024 or until a Highway Superintendent is hired. Upon roll call, the vote was as follows:

The Chairman declared the motion carried.

DRIVEWAY PERMIT

Lichti Farms submitted a request to add 50 feet to one side of an existing driveway and 60 feet to the other side of this driveway to the Board.

After discussion, Noel moved and Cerny seconded the motion to approve the request of adding fifty (50) feet to one side of an existing driveway and sixty (60) feet to the other side of this driveway due to safety concerns located on Road 6 between Road W And Road X in the NE ¼, Section 26, Bryant Township. Upon roll call, the vote was as follows:

The Chairman declared the motion carried.

DISCUSSION REGARDING WIDTH OF DRIVEWAYS WITHIN THE COUNTY

After discussion, Sluka moved and Lightwine seconded the motion to change the maximum driveway to sixty (60) feet without Board approval (used to be forty (40) feet). Upon roll call, the vote was as follows:

The Chairman declared the motion carried.

DRIVEWAY PERMIT

Curwin Elting submitted a permit for a three hundred forty (340) foot driveway. After discussion regarding the size, the Board requested that they reconsider their request. Curwin agreed to amended their permit to place two (2) eighty (80) foot driveways.

After further discussion, Harre moved and Lightwine seconded the motion to approve the amended driveway permit to install two (2) eighty (80) foot driveways in the SW ¼, Section 30, Bryant Township along Road X between Road 1 and Road 2. Upon roll call, the vote was as follows:

The Chairman declared the motion carried.

OTHER ROAD DEPARTMENT DISCUSSION

The Board and landowner Jeremy Fairbanks discussed the culvert that was damaged on Road K between Road 3 and Road 4 during harvest. After review and discussion, the Board agreed that they would be replacing this culvert with three (3) forty-eight (48) inch culverts to allow for more cover over the culvert.

Discussed having employees take time off without pay, there is a portion in the new handbook discussing this and the Board prefers this not take place.

Discussed purchasing a new flatbed for a pickup and a portable welder that was included in the budget. Board approved them to proceed with the purchase. Also discussed how to handle interviews and other personnel matters until a Highway Superintendent could be hired. The Chairman and Vice Chairman will assist with these personnel matters unless they are unavailable and then will request assistance from another board member.

DISCUSSION REGARDING CONTRACT WITH CITY OF GENEVA FOR LAW ENFORCEMENT

The Deputy County Attorney and County Sheriff reviewed the contract that was presented by the City of Geneva on October 3, 2023. After review the Deputy County Attorney drafted a letter listing their concerns with portions of the contract. After review of that letter, the Board agreed to have the letter sent to the City of Geneva for their review.

WHEREAS, Fillmore County has previously entered into Intergovernmental/Interlocal Agreements with other Nebraska Counites and other public agencies to form and participate in the Nebraska Intergovernmental Risk Management Association (NIRMA) and the Nebraska Intergovernmental Risk Management Association II (NIRMA II) as authorized by the Intergovernmental Risk Management act (Neb. Rev. Stat. §44-4301 et seq.) and the Nebraska Interlocal Cooperation Act (Neb. Rev. Stat. §13-801 et seq.); and

WHEREAS, Counties and other Public Agencies as defined in Neb. Rev. Stat. §44-4303 are allowed to participate in said cooperative undertakings; and

WHEREAS, the Legislature has found that proper risk management requires the spreading of risk so as to minimize fluctuation in insurance needs and that benefits can be derived through the pooling of insurance purchasing by local government, and

WHEREAS, NIRMA and NIRMA II have provided coverages to the County in a cost-effective way which meet and exceed that provided by standard insurance carriers; and

WHEREAS, NIRMA and NIRMA II provide risk management services such as loss prevention, safety audits and assessments, claims and litigation management, and coverages tailored to address loss exposures counties and other related public entities face not economically available from other sources; and

WHEREAS, these coverages and risk management services are essential for the continued effective and efficient use of county taxpayer dollars; and

WHEREAS, the current Intergovernmental/Interlocal Agreements will expire on June 30, 2024, and

NOW, THEREFORE, BE IT RESOLVED that Fillmore County Board hereby:

- 1. Extends its commitment to participate in NIRMA and NIRMA II for the period July 1, 2024 through June 30, 2027; and
- 2. Declares that this Resolution shall serve as an amendment and addendum to the previous Intergovernmental/Interlocal Agreements entered into by the County Board, said Intergovernmental/Interlocal Agreement readopted by and incorporated herein by this reference as amended.
